 3. The Company has prepared these Unaudited Financial Results in accordance with the Companies (Indian Accounting Standards) Rules, 2015 prescribed under Section 133 of the Companies Act, 2013.  
 4. Figures of the previous periods have been regrouped / restated wherever necessary.  
 5. The above results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on February 12, 2026.  
 6. **Cyber Fraud:** Subsequent to the quarter ended June 30, 2025 a cyber-fraud on the Company have been identified on July 2025, involving Rs.192 Lakhs. A FIR was lodged with the Cybercrime Authorities on the same day. As of the date of approval of these financial results by the Board of Directors, Rs.18 Lakhs has been recovered.  
 7. **Demerger:** The Company has applied to the Metropolitan Stock Exchange of India Limited (MSEI) on October 1, 2025, under Regulation 37 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, for the proposed Scheme of Demerger between Anglo-French Drugs and Industries Limited (the "Demerged Company") and AFD Enterprises Limited (the "Resulting Company") for the purpose of obtaining the No Objection Certificate (NOC). The NOC from MSEI is awaited.  
 8. **Deferred Tax:** The Company has neither ascertained nor accounted for the deferred tax for the quarter and Nine months ended December 31, 2025. It is consistent practice of the Company to account Deferred Tax at the end of the financial year.  
 9. **Regulatory Developments:** The Government of India has consolidated 29 existing labour legislations into a unified framework comprising four Labour Code viz Code on Wages 2019, Code on Social Security 2020, Industrial Relation Code 2020, and Occupational Safety, Health and Working Conditions Code 2020 (Collectively referred to as the New Labour Codes). These codes have been made effective from 21st November 2025. The corresponding all supporting rules under these codes are yet to be notified.  
 10. **Change of Registered Office Address:** During the quarter the Company received approval from the Ministry of Corporate Affairs (MCA) for shifting its Registered Office from Plot No.4, Phase II, Peenya Industrial Area, Peenya Bengaluru - 560058, Karnataka (CIN:L24230KA1923PLC010205) to Unit No.16C, 5th Floor, CWing, Phoenix House, Senapati Bapat Marg, Lower Parel, Deltale Road, Mumbai - 400013, Maharashtra (CIN:L24230MH1923PLC463682) on 13th November 2025. The Shareholders' approval for the said shift was obtained through a Postal Ballot, and the Special Resolution was duly passed on 5th June 2025.  
 The Company circulated a resolution to all Directors on 5th January 2026 seeking consent for shifting the Registered Office from Unit No.16C, 5th Floor, CWing, Phoenix House, Senapati Bapat Marg, Lower Parel, Deltale Road, Mumbai - 400013, Maharashtra to No.101, First Floor, Orbit Plaza, New Prabhadevi Road, Prabhadevi, Mumbai 400025, which was duly ratified, passed and lodged with the Registrar of Companies.  
 The said change has no impact on the Financial Results of the Company for the quarter and nine months ended December 31, 2025.


